## Important specifications of DEHS

Di-Ethyl-Hexyl-Sebacat (DEHS) is a no soluble, colourless and odourless liquid which is suitable for producing steady aerosols. The main proportion of droplets generated by aerosol generators series ATM can to be stated in the most penetration particle size (MPPS  $0.2...0.3~\mu m$ ). DEHS is a proven aerosol liquid for challenging clean rooms and laminar flow boxes. The long life time of droplets enables also to use the aerosol for stream visualisation. DEHS evaporates completely after long times. A droplet with a  $0.3~\mu m$  diameter has a life time of 4 hours.

#### Applications

- Generation of polydisperse aerosols with particle sizes below 1 µm for filter tests and challenging clean room equipment
- Production of seeding particles for stream visualisation
- Generation of monodisperse aerosols for aerosol research applications by using the condensation principle




Figure 1: Vapour Pressure Dependency of DEHS
